

# CUSACK'S POLICE REPORT ON THE REVENGE TAKEN AGAINST HIM!

## CHAPTER 62

*(Editor's Note: By popular demand we are rerunning the police report that we previously spread over several weeks so the thousands of new readers coming to the site can catch up on what took place.*

On October 29, 2014 I was on duty in a utility Sergeant position. At approximately 1030 I received a phone call at my desk from Andrew CUSACK. CUSACK is well known to me and I have a good working repour with him.

CUSACK sounded like he was in pain and needed my help. We briefly talked about an assault that happened on him in the early morning (0230) and had just ended when he called. I told CUSACK that I would respond to his house to assess the situation with the help of a detective and evidence officer. I asked CUSACK if he needed medical attention and responded that he did, but he didn't want people at his house and would go to the hospital after we spoke. One last thing CUSACK mentioned was that his small finger was exposing bone and would probably need surgery.

A short time later, I left the station with Detective Blatchford following me and Evidence Tech Nelson shortly after that. I arrived at the house located at 179 Holmes Road and was met by CUSACK's brother Glenn and his son. Sergeant Pearson was there as well. I had a brief conversation with them before entering the house.

Once in the house, I was met by CUSACK. CUSACK was bleeding from several places on his body. Given the severity of his bad appearance, I was surprised to see CUSACK conscious and alert. It was apparent that CUSACK was in serious pain and he was holding his left side. Visual injuries that were observed while I was present were:

1. Left eye black
2. left eye cut on upper lid probably requiring stitches
3. broken nose
4. right cheek injury
5. broken ribs (several)
6. deep laceration on the right calf probably requiring stitches
7. left pinky finger probably requiring attention
8. other injuries to his ears and head but covered by hair
9. injury to right hand

There were several other cuts and bruises, but I was unable to see the extent of them. Because of the pain CUSACK was revealing, it was determined to forgo an interview until he got medical treatment. While the rescue was in route, Detective Blatchford was able to get the suspects name and other important things to help locate the suspects. Reference can be made to Blatchford's case narrative.

A short time later the rescue arrived and began medical treatment. If the rescue started treatment, I met with Evidence Tech Nelson to see if he needed anything else. I left and returned to the station.

On October 29, 2014 at approximately 10:55 hrs. I (Detective Donald Blatchford) was notified of a possible assault that had taken place on a Mr. Andy Cusack at his home located at #179 Holmes Road in Scarborough. I was assigned to respond to the scene and assess the situation. Sgt. Steven Thibodeau and I arrived at the scene at approximately 11:15 hrs.

Upon our arrival we were met by Andy Cusack's brother Glenn and his nephew Nick who were out in the driveway, also with them was Sgt. Mary Pearson who was off duty and I assumed had responded to the scene from her home, likely at Mr. Cusack's request as she is a friend and lives a short distance away. Sgt Pearson began to explain that Andy was in his house and that he was beaten up pretty bad, but able to talk. She advised that there were tire marks from the suspects vehicle in the driveway as well as evidence in the bark mulch area by the entrance door related to the assault. I viewed a sweater that was laying in a disturbed area of the bark mulch which appeared to have been torn. Sgt. Pearson indicated that this location was one of the areas where the beatings had taken place, but there was more inside the residence. She also mentioned that there was some duct tape which had been used to restrain the victim in the front yard with blood on it. I observed the garage door farthest to the right was open and no vehicle was in that bay. I was told that the suspects had taken the Chevrolet Corvette that was in that bay with them when they left.

I then entered Mr. Cusack's home and observed blood on the entry porch as well as in the carpet at the entry door. Once inside I observed the victim, Andy Cusack 12/23/1964, standing somewhat slumped over in the kitchen area of the home. Cusack had obvious significant injuries to his head, face, ears, rib area, back, legs, arms and apparently a compound fracture to a finger on his left hand which was wrapped when I arrived. He had also applied bandages to an injury on his leg and was literally covered in blood from head to toe. My initial reaction to his appearance was to ask if rescue personnel were on the way. Mr. Cusack responded by stating that he did not wish to have rescue respond, stating that he wanted to make sure we were given what we needed for information and then he would have his brother transport him to the hospital as he suspected he would be needing surgery and unavailable for a period of time after. I explained to him that we could get the details later, but that I was very concerned about the extent of his injuries and I implored him to reconsider. He stated that he would be OK and began to provide me some of the details about what had happened. He stated that there were two individuals involved, one who he has known for some time who, he advised, Scarborough Police had taken a complaint from last year accusing Mr. Cusack of inappropriate behavior (see C#13-731-OF). I am familiar with this prior report. Mr. Cusack then went on to identify his primary assailant as Sean Caisse DOB: 01/30/1986, who was in fact one of the people who had filed that prior complaint. Mr. Cusack then stated that the 2nd suspect was a female identified to him as Caisse's new girlfriend. He stated that he believed her name was Chelsea and that her last name may have started with DU, but he could not remember what the last name was. He told me they had arrived in a White in color Ford Truck or SUV with North Carolina plates on it. He stated that when they left they took his Silver 2002 Chevy Corvette out of his garage as well as their truck. He stated that for the most part Chelsea did not take part in the physical beatings, but she assisted Cassie with restraining him and she did take an active part in everything that occurred that morning to some degree. He stated that he was tied up, beaten with a club, duct taped to prevent him from fleeing or fighting back and otherwise abused over a period of several hours during the overnight and into the morning hours. He stated that he was forced to sign over paperwork to the Corvette and he was also forced to sign a check for \$7500.00 and was told that he had to send \$7500.00 a month to Caisse from this point on. He stated that he was tied to a chair and beaten as well as beaten and dragged around both in the home as well as outside at times. He stated that at one point Caisse had removed his pants and grabbed a hold of his penis and genitals squeezing them to inflict pain as well as dragging him about the living room area by his penis, all the while beating him with the club or

baton he had. He stated that he was struck with a club in genital area as well as his buttocks area. He was beaten on his head, his torso and about every other location of his body throughout the time that they were there. He stated that before they left they threatened him multiple times, stating that they had access to a hit man who would come and kill him as well as threatening his reputation with his friends and in his business associates within the racing community if he were to report this incident to anyone. Mr Cusack owns and operates Beech Ridge Motor Speedway, a NASCAR track here in Scarborough. Mr. Caisse was a race car driver who at one point raced at the track. Mr. Cusack and Sean Caisse have had a relationship over the years that has yet to have been fully explained. I did not ask for too many details at that point.

Evidence Technician Detective Ron Nelsen then arrived and I went outside to meet with him. I explained to him that I was very concerned about the extent of Cusack's injuries and that he was adamant that he was not leaving until we were able to get what we needed, such as photographs etc. I asked that Detective Nelsen take what photos were necessary and then help me convince Cusack to get some medical attention. Detective Nelsen then did just that and agreed that the obvious injuries were so significant that he should be attended to ASAP. Mr. Cusack then finally agreed to go with the rescue to the hospital. Detective Nelsen remained at the scene to do evidence processing. Sgt. Mary Pearson went with Mr. Cusack to the hospital. I returned to the Scarborough Police Station to begin the process of sending out teletypes via NCIC to attempt to locate and arrest the suspects in this case.

Investigation revealed that the stolen vehicle as well as the White Ford were seen getting onto I 95 at the Scarborough toll booth at approximately 10:20 hrs. Caisse was believed to have been driving the Corvette at that time and the female, Chelsea, would have been driving the Ford. The Ford is likely Caisse's 2013 Ford F150 which is registered to him in North Carolina and has NC Registration plate # CAW5496 on it.

Follow up with Sgt. Pearson at the hospital revealed that Cusack is believed to have broken at least 6 ribs and possibly punctured a lung, he has a broken nose and a broken finger on his left hand which will require surgery. He has several deep lacerations to his head face and leg which will all require stitches and staples. It was also learned that the suspects had a german sheppard dog with them that inflicted the wound to his leg. Apparently the dog bit him during the assault.

Investigation continues.
